4. Description of the Study and Purposes of Processing Personal Data

The SuMoS Project is a joint consortium of five project partners, coordinated by the University of Zagreb and funded by the European Union Erasmus + Program. The aim is to create an institutional student mobility ecosystem (ISME) supported with the involvement of green practices, mechanisms and human capacities within HEIs for comparison of courses and digitalization of the student mobility at the institutional level by designing and piloting digital services based on AI-supported rule-based platform, and their evaluation and verification in international context. 9. Duration of the Study

The SuMoS Project is expected to continue until 09/2027.

10. Lawful Basis for Processing

The lawful basis for processing is Article 6(1) of General Data Protection Regulation: performance of a task carried out in the public interest or in the exercise of official authority vested in the controller: scientific or historical research purposes or statistical purposes.

Data will be shared only with project partners for research and development. Anonymization will be applied before sharing.

12. Automated Decisions

No automated decisions will be made with your data.

13. Safeguards to Protect Personal Data

Personal data will be securely stored and restricted to necessary project staff.

14. Processing Post-Study

Data will be stored in anonymized form at the end of the project (09/2027).
